

POTENTIAL SURROGACY JOURNEY COSTS

We understand that surrogacy journey costs are a considerable expense for ALL intended parents. For this reason, we are providing an estimate of potential surrogacy journey costs so that you can better prepare for your journey. **Total cost for one surrogacy journey may range from \$140,000 to \$150,000+.**
